- I agree to pay the rates that are in effect at the time my pet is at Luv-d Pugs

At time of **dropoff of pet in cash. During summer months, I require a deposit to be mailed to me for your spot to be held. Please pay at least ½ of the bill in cash. I cannot accept terriers.**

**(All males must be neutered. I show my female pugs and they are not spayed.)**

**Fees are as follows: My rates have increased after July 19<sup>th</sup>.**

**Daycare \_\_\_\_\_ \$15 a day, 8-10 hours.**

**Overnight Boarding: \$25 to new clients for a 24 hour period  
after 24 hours \$10 for daycare will be added.**

**2 dogs- \$40 Overnight.**

**After 5 nights, rate discounted to \$20 a night 1 dog.**

**Former Clients 1 dog \$20, 2 dogs \$35.**

**Checks will be accepted at time of dropoff.**

**A bank charge fee will be added if check is returned.**

I am aware that extra charges may be incurred and I agree to pay them at the time of pick-up. Examples include, but are not limited to: Daycare, boarding, Vet care, medications, grooming.

· I understand that there is a minimum \$100.00 boarding deposit for **holiday boarding** and is non-refundable if I cancel my boarding reservation. · If my dog participates in daycare and or boarding, I understand that an interactive play setting is not without some risk of injury, that despite all the dogs appearing healthy and being handled with the greatest amount of care and foresight, dogs are not always predictable in the unexpected may occur. I recognize that the benefits of an interactive playgroup are valuable to my dog, and accept the potential risks. I further agree to pay veterinary/medical expenses incurred as a result of injury to or caused by my dog.

· If my pet appears to be ill, I authorize Luv-d Pugs Boarding to engage the services of a veterinarian at my expense, to give other requisite attention, and to make whatever decisions are required for my pet's veterinary treatment. I agree to pay all veterinary charges incurred by my pet while in the care of Luv d Pugs. I will not hold Luv-d Pugs Boarding liable for failure to seek veterinary attention or for decisions made under this contract.

· I understand that Luv d Pugs will exercise all due diligence and care in the guardianship of my pet. I hereby waive and release Luv-d Pugs, its employees, owners and agents from any and all liability of any nature, for injury or damage, including that which may result from the action of any dog including my own, and I expressly assume the risk of such damage or injury while my dog participates in or attends any function of Luv-d Pugs, while on the grounds or the surrounding area thereto.

· I understand that I am required to provide Luv-d Pugs documented vaccination records and to keep the vaccination up-to-date for the duration of my dog participation.

### **Luv-d Pugs Rules and Requirements**

To ensure the health and safety of your pet and of our other guests, we require that all of our clients comply with the following rules and regulations.

1. All dogs must be at least 4 months of age or older. All dogs over the age of 7 months must be spayed or neutered. Puppies and shelter dogs must be in the home for 1 month prior to coming to daycare.
2. If dogs prove to be markers or habitual wetters; belly bands will be put on the dog for training purposes.
3. All dogs must have up-to-date vaccinations. Owners must submit written proof that their dogs have current DHPP Parvo, distemper, rabies and bordetella (kennel cough) vaccinations.
4. All dogs must be in good health. Owners will certify that their dog(s) are in good health and have not been ill with a communicable condition in the last 30 days. Upon admission, all dogs must be free of any condition that could potentially jeopardize other guests, including fleas or ticks. Dogs that have been ill with a communicable condition in the last 30 days will require veterinarian certification of health to be admitted or readmitted.
5. Owners will need to certify that their dog(s) have not harmed or shown aggression or threatening behavior towards any person or other dog(s).
6. All dogs must have a complete, up-to-date and approved application on file prior to attending daycare and boarding.
7. Owners please bring your own dog food, bed, and favorite toy or blanket.
8. If a pet that is presented for daycare or overnights is found to have fleas and/or ticks, it will be bathed at the owner's expense.
9. If dog is not picked up at time defined and left for more than 14 days (abandoned) per City of Orange Animal Control, it will be put up for adoption or taken to a rescue.

## **Certificate of Health and Temperament**

1. I (the owner) understand that if my dog(s) has a history of aggression or biting, excessive barking or jumping fencing, Luv-d Pugs reserves the right to refuse service. If at the time of boarding and dog cannot be picked up in a 24 hour period by owner or authorized person, dog will be taken to a vet for boarding at owners expense.
2. I understand that I am liable for any medical care expenses and damages that result from injuries caused by my dog(s).
3. I expressly wave and relinquish any and all claims against Luv-d Pugs its employees and representatives, except those arising from negligence on the part of Luv-d Pugs.
4. I have disclosed all known dangers associated with my dog(s).
5. I expressly understand and agree that Luv-d Pugs shall not be held responsible for any damage to my property, or that of others, caused by my dog(s) during the period in which they are in its care.
6. I understand that under no circumstances will Luv-d Pugs be liable for consequential damages or damages beyond the replacement value of my dog(s).
7. If any medical problems develop while my dog(s) is in the care of Luv-d Pugs, I authorize to do whatever they deem necessary for the safety, health and well being of my dog(s). Further, I agree to assume full financial responsibility for any and all expenses incurred.
8. I understand that is a cage-free facility. I accept the risks involved and agree that Luv-d Pugs is not liable for any injuries or illnesses resulting during my dog's attendance.
9. I hereby declare that I am legal owner of my dog; that my dog has **not** been exposed to distemper, rabies or parvo within the past (30) thirty days; that my dog(s) has been inoculated as indicated by records presented; that my dog(s) is currently and properly licensed; and that I (the owner) have read this agreement in its entirety.
